## SECTION IV – FIRST AID INFORMATION

### First Aid Procedures:

Eye Contact:	Promptly wash eyes with plenty of water while lifting the eyelids. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Call a physician or Poison Control Center immediately. Obtain medical attention and take along these instructions.
Skin Contact:	For skin contact flush with large amounts of water. If irritation persists get medical attention. Immediately take off all contaminated clothing. Wash separately before reuse.
Inhalation:	If symptoms are experienced, remove source of contamination or move victim to fresh air. If symptoms persist, get medical attention. If the affected person is not breathing, apply artificial respiration. If breathing is difficult, give oxygen. Get medical attention immediately.
